

THE “B-VIP” CONTEST **OFFICIAL RULES**

1. **Dates/Eligibility.** The “B-VIP” Contest (the “Contest”) begins Thursday, June 6, 2019 and ends on Friday, June 28, 2019. WUBE (the “Station”) may change the dates and/or terms of the Contest, including canceling the Contest, without prior notice. Any material changes will be broadcast on the Station and posted online on a page at www.b105.com (the “Site”). The Contest is open to all legal residents of Ohio, Kentucky or Indiana, thirteen (13) years of age or older at the time of entry. Winners who are younger than 18 years old will be required to have a parent or legal guardian accept their prize and sign a release. There is no purchase necessary to enter or win. A purchase will not increase a contestant’s chance of winning. The Contest is void where prohibited by law. Employees or agents of the Station, Hubbard Broadcasting, Inc., Riverbend Music Center, any entity associated with the sponsorship or administration of the Contest (collectively, the “Sponsors”) or any other television or radio station that transmits a signal for reception in Ohio, Kentucky or Indiana, as well as members of the same household of any such employee or agent, may not participate. No more than one (1) winner per household. Contestants can only win once per day. Previous winners of contests conducted by the Station must comply with the following time limit before attempting to enter the Contest: Contestants may only win one prize per person valued at or above \$10,000 every six months unless specified otherwise. Each time limit is measured from the date the winner won their prize in the prior contest.

2. **How to Enter.** To participate in the contest, contestants must listen to WUBE every Thursday and Friday during the contest period and call the station’s contest line (513) 749-2105 when prompted by a “cue to call” (the “Cue”). The Cue will be played once per hour from 9:00 a.m. until 5:00 p.m. each day. The 10th caller that successfully calls in will win tickets to a Country and also be qualified into the Weekly grand prize drawing.

3. **Selection of Winner.**

- a. Winners must listen to win pursuant to section 2 of these official rules. Winners will be notified on-air.

4. **Prizes.**

- a. Hourly prize for Thursday, June 6, 2019 and Friday, June 7, 2019 is a pair of lawn tickets to Brad Paisley concert at Riverbend Music Center on Sunday, July 21, 2019 (approximate retail value = \$67.00). Weekly grand prize drawing prize: pair of passes to meet Brad Paisley (arv = na). This weekly grand prize drawing occurs on Friday, June 7, 2019 at approximately 5:00 p.m.

- b. Hourly prize for Thursday, June 13, 2019 and Friday, June 14, 2019 is a pair of lawn tickets to Brantley Gilbert concert at Riverbend Music Center on Thursday, June 20, 2019 (arv = \$66.00). Weekly grand prize drawing prize: pair of passes to meet Brantley Gilbert (arv = na). This weekly grand prize drawing occurs on Friday, June 14, 2019 at approximately 5:00 p.m.

c. Hourly prize for Thursday, June 20, 2019 and Friday, June 21, 2019 is a pair of lawn tickets to Thomas Rhett concert on Friday, August 9, 2019 (arv = \$68.00). Weekly grand prize drawing prize: pair of passes to meet Thomas Rhett (arv = na). This weekly grand prize drawing occurs on Friday, June 21, 2019 at approximately 5:00 p.m.

d. Hourly prize for Thursday, June 27, 2019 and Friday, June 28, 2019 is a pair of lawn tickets to Jason Aldean concert at Riverbend Music Center on Thursday, August 22, 2019 (arv = \$68.00). Weekly grand prize drawing prize: pair of passes to meet Jason Aldean (arv = na). This weekly grand prize drawing occurs on Friday, June 28, 2019 at approximately 5:00 p.m.

e. There will be up to sixty-four (64) qualifying prizes awarded.

f. Winners will be required to complete an IRS Form W-9 and will receive an IRS Form 1099-Misc. Winners who are younger than 18 years old will be required to have a parent or legal guardian accept their prize and sign a release.

i. WUBE is not responsible for replacing concert tickets for a show that has been cancelled for any reason.

5. **Conditions/Restrictions.** In exchange for the right to participate in the Contest, each contestant agrees to release and indemnify each of the Sponsors, and the officers, directors, agents, parent companies, subsidiaries and employees of each of the Sponsors, for, from and against any and all claims, demands and/or causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the contestant's participation in the Contest and, if the contestant is the winner of the prize, the use of their prize. Entry into the Contest constitutes permission for each Sponsor and its respective designees to use the contestant's name, likeness, portrait, voice and/or biographical material for an unlimited period of time in order to advertize, promote or publicize the Sponsor and/or the products and services of any of its designees. Winner will be required to produce identification satisfactory to the Station and sign an affidavit of eligibility and release (including a publicity release) as prepared by the Station. Anyone using fraudulent means to participate in and/or win the Contest will be subject to disqualification.
