

**THE “HOMEARAMA / B-105 50<sup>th</sup> BIRTHDAY SHE-SHED” SWEEPSTAKES**  
**OFFICIAL RULES**

1. **Dates/Eligibility.** The “Homearama / B-105 50<sup>th</sup> Birthday She-Shed” Sweepstakes (the “Sweepstakes”) begins Saturday, June 8, 2019 and ends on Sunday, June 23, 2019. WUBE (the “Station”) may change the dates and/or terms of the Sweepstakes, including canceling the Sweepstakes, without prior notice. Any material changes will be broadcast on the Station and posted online on a page at [www.b105.com](http://www.b105.com) (the “Site”). The Sweepstakes is open to all legal residents of Ohio, Kentucky or Indiana, eighteen (21) years of age or older at the time of entry. There is no purchase necessary to enter or win. A purchase will not increase a contestant’s chance of winning. The Sweepstakes is void where prohibited by law. Employees or agents of the Station, Hubbard Broadcasting, Inc., Homearama, the Home Builders Association of Greater Cincinnati, Backyard Buildings and More, Sacksteder’s Interiors, any entity associated with the sponsorship or administration of the Sweepstakes (collectively, the “Sponsors”) or any other television or radio station that transmits a signal for reception in Ohio, Kentucky or Indiana, as well as members of the same household of any such employee or agent, may not participate. No more than one (1) winner per household. Contestants can only win once per day. Previous winners of contests conducted by the Station must comply with the following time limit before attempting to enter the Sweepstakes: Contestants may only win one prize per person valued at or above \$10,000 every six months unless specified otherwise. Each time limit is measured from the date the winner won their prize in the prior contest.

2. **How to Enter.** There are two ways to enter the Sweepstakes. Only one entry per person via either method of entry below.

- a. Contestants can fill out an official entry form at Homearama at Kensington of Mason during normal operation hours.
- b. Contestants can enter via a web page at [www.B105.com](http://www.B105.com)

3. **Selection of Winner.** Winner will be selected via a random drawing from all eligible entries via either method above. Winner will be notified via phone. If winner cannot be reached within 48 hours, another random drawing will occur. Winner must have at least a 10-foot opening through any fence line in order to deliver the shed through to the backyard. Winner must also take possession of prize by Friday, June 28, 2019.

4. **Prize.**

- a. There is one grand prize in this Sweepstakes. It includes:
  1. a 12’ x 8’ Heartland Stratford Shed which includes installation, floor upgrade, paint and delivery. Valued at \$3,226.
  2. Sacksteder’s Interiors will provide the furniture and accessories needed to decorate the shed. Valued at \$3,000.
  3. Total prize value: \$6,226.
- b. Grand prize drawing will occur on Monday, June 24, 2019 at approximately 9:00 a.m.

- c. Winners will be required to complete an IRS Form W-9 and will receive an IRS Form 1099-Misc.

5. **Conditions/Restrictions.** In exchange for the right to participate in the Sweepstakes, each contestant agrees to release and indemnify each of the Sponsors, and the officers, directors, agents, parent companies, subsidiaries and employees of each of the Sponsors, for, from and against any and all claims, demands and/or causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the contestant's participation in the Sweepstakes and, if the contestant is the winner of the prize, the use of their prize. Entry into the Sweepstakes constitutes permission for each Sponsor and its respective designees to use the contestant's name, likeness, portrait, voice and/or biographical material for an unlimited period of time in order to advertise, promote or publicize the Sponsor and/or the products and services of any of its designees. Winner will be required to produce identification satisfactory to the Station and sign an affidavit of eligibility and release (including a publicity release) as prepared by the Station. Anyone using fraudulent means to participate in and/or win the Sweepstakes will be subject to disqualification.
